Terms and Conditions

THE PREFERRED CUSTOMER PROGRAM: I acknowledge and understand that the PureWorks Preferred Customer Program provides to me, as a Preferred Customer, the opportunity to purchase PureWorks products at the wholesale Distributor price as long as I agree to purchase and take delivery of one or two cases of PureWorks products, as described above, on a monthly basis, and agree that I will not resell any such products unless I become a PureWorks Distributor. The designated AutoShip Package will be sent to me each month, regardless of any other purchases I may have made during the month.

PAYMENT AUTHORIZATION: I authorize PureWorks to withdraw payment for my designated AutoShip Package(s) from my card or bank account identified on the front of this Agreement. If I have elected to pay by checking account debit, I hereby authorize PureWorks to electronically withdraw payment from my checking account for orders I place directly and for my monthly AutoShip Package(s), as authorized in this Preferred Customer Agreement. PureWorks is authorized to withdraw payment equal only to the amount of the products, applicable sales tax, and shipping and handling of products that I order, or the AutoShip Package(s) that I have selected. I agree to pay a \$20.00 service fee in the event a check or charge is returned for any reason. I have the right to have the amount of any erroneous withdrawal deposited into my account as soon as reasonably possible and upon proper notification to PureWorks. I shall hold PureWorks harmless from and against any and all special or consequential damages, whether direct or indirect, resulting from any wrongful debit to my account.

CHANGES: I understand that: (i) I may change my AutoShip Package selection(s), method of payment and the authorized amount by submitting a new Preferred Customer Agreement to PureWorks; (ii) if I have submitted more than one Preferred Customer Agreement to PureWorks, the most recent Agreement will supersede all previous Agreements; and (iii) PureWorks reserves the right to change any price associated with its products without notice.

TERM: I understand and agree that this Preferred Customer Agreement will remain in effect until I: (1) elect to alter or change any aspect of this Agreement by submitting a new signed Preferred Customer Agreement to PureWorks; (2) send, in writing, written notice of my desire to cancel this Agreement to PureWorks at 4120 South 500 West, Salt Lake City, Utah 84123, or by fax to (801) 207-4645 (which notice must include my signature, printed name, address, and customer ID#); or (3) stop payment of any withdrawals by PureWorks by notifying my issuing bank at least three days prior to the next scheduled charging of my account. I further agree that notice of cancellation must be received by the fifth day of the month in order to avoid charges for that month, and that, if a cancellation notice is received after the fifth day of the month, cancellation will become effective in month following the month in which my notice of cancellation is received by PureWorks.

NOTICE OF RIGHT TO CANCEL

You may CANCEL this transaction, without any penalty or obligation, within THREE BUSINESS DAYS from the above date.

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within TEN BUSINESS DAYS following receipt by PureWorks of your cancellation notice, and any security interest arising out of the transaction will be canceled.

If you cancel, you must make available PureWorks at your residence, in substantially as good condition as when received, any goods delivered to you under this contract or sale, or you may, if you wish, comply with the instructions of PureWorks regarding the return shipment of the goods at the expense and risk of PureWorks.

If you do make the goods available to PureWorks and PureWorks does not pick them up within 20 days of the date of your Notice of Cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to PureWorks, or if you agree to return the goods to PureWorks and fail to do so, then you remain liable for performance of all obligations under the Agreement.
